Budget Overview - Corey Baker

- a. Purpose: Important to understand how to evaluate budgets, and trust the Finance Zone
- b. Budget Types: Zero based, Revenue generating, Expense based
 - a. Which budgets fall in which categories, what happens when expenses are less than expected, what happens when expenses are greater than expected



- Indirect Cost Recovery (IDCR) Procedure for recovering "administrative" or "programmatic" costs incurred by WHQ while working towards the goal for the society, but cannot be identified and marked to a specified program.
 - a. E.g. utilities, mortgages, salaries & benefits, building, maintenance, etc.
 - b. Who pays/receives IDCR?

Alcohol/Drug Abuse Taskforce Recommendations - Avery Williams

- a. Problem Definition: Who- predominantly collegiate members, typically not chapter leadership, members that do not participate in agenda, new members
- b. Problem Definition: What dangerous drinking/drug use, tarnished reputation of the organization, liability
- c. Problem Definition: When/Where after hours, party starts in individual rooms, social media exacerbates our problem
 - a. Does not start after last agenda item
 - b. Internal issues become public quickly, without our knowledge
- d. Problem Definition: How Members come prepared to party, of-age members buy drinks for younger ones, everyone believes they can drink responsibly
- e. Problem Definition: Why Convention is a vacation to many, learned behavior, technological divide, NSBE has failed to adapt to its size, CPC, NEB, and REBs are not enough to police our conventions, we don't know how to police ourselves, we cram too much into the conf/conv agenda
 - a. Not unique to NSBE
 - b. "We forgot [how] to take care of each other"
 - c. Members no longer respect NSBE leaders as authorities
 - i. 20yo policing other 20+yo is ineffective
 - d. We attempt to keep things "in house" in an effort to shelter our members from the real world
 - e. There is only one real time period to be together socially
- f. Recommendations:
 - a. Enforce Code of Conduct
 - i. Our threats have no teeth without enforcement through the SEC
 - b. Clear marketing strategy on what convention is and what it is not
 - i. "How to Sell Convention to Your Chapter" Toolkit
 - ii. Ensures that the message that the individual member receives is one that we are proud of
 - c. Dry conferences/convention
 - i. Attack our issue head on
 - ii. Acknowledge the severity of the problem
 - iii. No tolerance
 - d. Eliminate parties all together
 - e. General Questions

- Gabe: We do well talking about it, in terms of personal experiences
- Valerie: We need to do a better job of helping our chapters understand what their overall GPA is (especially in comparison)
- Harry: Chapters don't really know what Retention Program entails. How do you know where your chapter stands? (chapter assessment tools)
 - Vernon: Received comments from chapter leaders about how to make members value it as much as the leaders do?
- Jasmine: Disconnect between us talking about AEx and membership doing AEx. Members don't want to come to AEx events in comparison to social events. Figuring out how to retain members in engineering; how do we help our leaders inspire their members?
- Shuffarel: Showing that we're about it, rather than just saying it's about the membership. We do a good job rewarding APEx members, but there's a disconnect between rewarding and encouraging others to get to that level.
- · JaRod: Strongly recommended that chapters participate in academic program; indicated importance of study hours and increased a competitive atmosphere for Chapter of the Year.
- Sukari: Unless there's an incentive to come out, members think it's more beneficial to study at home. Having a MEP or other multicultural program improves accountability and therefore performance. Clusters versus one unit. It's all about combining incentive and finding an invested administrator that would assist.
- Jasmine: Chapters don't know how to go about Academic Excellence; don't realize that that's part of the reason why NSBE was founded. Can we change the tone that the chapters are setting from day one?
- Donna O: Repetition is the basis of culture change. "I'm going to have a higher GPA with NSBE."
- Carl Mack: Why are we doing retention? (Question 0)
- Shuffarel: "Building an academic community" (tagline)
- Jasmine: We Drop Knowledge, Not Classes. Starting to receive inquiries about the data, which means that the message is starting to get out.
- S. Gordon: Must be able to get people to follow you (lack of comfort with building personal relationships). We have leaders of the population that we are trying to lead.
- Makita: The unified/community model does work (living together, studying together, etc.). Explain it to people to understand how to get there.
- Harry: We need to start seeing actual numbers. (Showed data from R4 RLC presentation)
- Jessica: Just studying with people in NSBE did not get the grades for people at PWIs. Need to encourage the utilization of other resources.
- Gabe: Example RAMP program, building the culture on a chapter level.
- Tiffani: National leadership needs to be more transparent in Academic struggles to engage them more in what NSBE has to offer. Encourage seniors to go to summer bridge programs. Discussion regarding personalization of Retention Program.
- Calvin: Everyone on the board sharing their GPAs = very powerful. Including items like that in the Retention Program. Work has to be with the expectation of long term. "NSBE, the academic society."
- Carl: Test bank ethics. The data is clear that those who participate in summer bridge programs do much better than those who don't. If we only get graduating seniors into those programs we can move the needle. Work to influence environment for freshmen and sophomores. We're receiving GPAs because of scholarships.

APC Proposal - Ahmed Awadelkarim

I move to approve the previously adopted bylaw.

Maker: Ahmed Awadelkarim Seconder: Gabe Draper Maker speaks to motion:

APC currently consists of Chair, Treasurer, Emeritus, and an appointed NEO member, 2 advisors Attempting to be somewhat more transparent to the board

- Would like to add two additional members of the NEB to the APC
 - Believe that this number would prevent confidentiality issues
- Members (excluding Chair and Treasurer) must be approved by NEB
- NEB may remove any member of the APC with ¾ vote

Seconder speaks to motion:

Makes it more transparent and processes more understandable

Discussion:

Keith – not an issue of adding people, but of accountability;

Committees don't operate purely on the will of the chair

Corey – Not really fixing the process, because it's more about informing the members; committee is taking work away from the board to alleviate issues of confidentiality, etc.

- Goal is not to change whether people do not report, assumption is that it will continue to not report
- We would know that the will of the board is included with any voting times

Tony – hearing that you want more of a "voice" from the NEB; the issue that you want to address is the reporting, not sure that the increase of the number will alter that; perhaps the advisors don't vote?

Doesn't look at the committee questioning what is the litigation risk, but we need to know that the NEB is responsible for the decisions made

Donna O. – understand your concern about feeling like you're blindsided and; important for APC to protect us legally, nature of APC is someone who has experience in the administrative concepts

Not comfortable with compromising on this (and altering the changes)

Steve – Sounds that this is a behavioral issue, have seen people added in other organizations; would rather have people removed or advisors not able to vote; more important in the accountability

Understand that it's behavioral, but recognize that you can't change that usually; so needs to be done through a structural change; nothing you can do in a proposal to address structural changes

Sossena – all committees are supposed to report quarterly and it doesn't happen; APC has become more



transparent over the years; large part is in NEB asking questions; overview of types of topics; sensitivity of items may affect peoples' jobs/career

Weight of APC decisions is all of those things; we are a board of directors, so everyone should be comfortable making those important decisions (otherwise, should you be on the NEB and should we be

JaRod – don't see reporting aside from what Sossena has indicated; see Ahmed's point to be developed as leaders, ad understand that we're affecting individual's lives

Virginia – the APC is supposed to support the WHQ staff; if we're going to make changes it's got to be about them Jasmine – problem is the "black box" itself rather than the people in it; the discussion before the APC conversation needs to be primary focus; make sure that the transparency isthere

Boards have been talking for the last 10 years so this is the time to discuss/vote

Shuffarel – NEB members may not feel comfortable coming to the APC; trust in the NEB as well; learning on the job is part of the NEB, not sure it's an issue of everyone not understanding how to make decisions

Bri – not sure that the "voice" is the problem because we do gather information from the board;

Emphasis about sending out the agenda beforehand; new information in certain decisions that the board may not know about

Donna O. – would you reconsider to being open to a friendly, because there are certain components that shouldn't be lost if some people are on the number

Feels that the request to compromise has continued over the past few years; have already significantly adjusted; everyone feels that they are not part of the decision-making process; not willing to compromise

Sossena – board opinion is extremely important; understand that there are processes outside of the ED discussion

- Ahmed sets the direction of the organization in the long run so this example isn't necessarily good
 - o Jasmine confirmation of who is on the board; there would be two additional bodies; concerned that this is going to get tucked away

Jessica – current members are so far removed from membership, so another voice closer to the members could be beneficial
