- The task force was formed at NTM to address the issues we had with excessive drinking at Annual Convention

- Recommending a visible campaign and pushing the code of conduct

Chairman Young - The task force will come back with a draft policy that will give the SEC the flexibility to deal with things on a case-by-case basis but guidelines for severity

Strategic Planning Session Update

Tony Harris

- Goal was to get renewed commitment from committee and adjust deliverables and timelines

- Did process review from original meeting and then looked at strategic decisions
